

Minutes of the Board Meeting

Monday 7th July 2025

1. Welcome, Apologies and Board Interests

The Commodore welcomed everyone to the meeting and asked members to notify of any conflicts of interest that may arise during the meeting.

7. Sailing Secretary's Report

We are now in the latter half of Series 2 and are fortunate in having all races as scheduled. The Primary Points in the Dinghy Tuesdays has been completed, and we are now into the Holiday Points. Again, all races have been run as scheduled. The Dinghy participants are still only numbering 3 – 4, whilst the turnout in the Wednesday Series is averaging 12.

Unfortunately, the decision made by the Board at the meeting on 7th April re the awarding of average points, wasn't implemented in the Sailing Instructions, and caused slight controversy with the Series 1 dinghy results. This was resolved, and the Sailing Instructions have been altered accordingly.





A proposal, aired at the last Board meeting, to alter the order of the Class starts, is being adopted. Parties with an interest have been consulted, and accordingly in Series 3, which commences on 23rd July, the Handicap White Sail will start first at 1910, the FF and Dinghies at 1915, and the Pipers at 1920. Continuation of this next season will rely on the feedback.

In the Cadets, a sufficient number are now considered competent enough to be introduced to racing. Commencing Tuesday 12th August, there will be a Topper Class starting after the Dinghies. HM, who was instrumental in putting this idea forward, will be providing Safety Boat cover.

Two Pipers attended the Ashton and Cove Regattas and also the Titan Spirits OD Regatta at RGYC. This latter was also attended by four Flying Fifteens. Neil Wilson in his Contender sailed in the Toward Regatta. The Piper Anniversary Regatta held here was a great success, with boats from RGYC journeying over to compete. Iain Hurrel was successful at all events closely followed by Stuart Brown, and in the FF Chris Bowen and Ally Marshall were up there.

 wish to do any work around the club such as weeding should feel free to do

The main outcome of these alterations is to provide an inclusive toilet and to give young people a safe and private space for changing and showering.




It was agreed that it would be good to have a proposal to present to members at the AGM in November.
